

CALL FOR ENTRIES — STOVER MILL GALLERY

October 2017 Juried Exhibition

PROSPECTUS

Eligibility: The exhibit is open to artists working in all mediums. Giclee reproductions are not appropriate. All works must be for sale and the Stover Mill Gallery retains a 30% commission on all sales.

Jury Process: The invited jurors will meet after September 6th to review submissions. All works are considered in a blind jury process based on artistic excellence and aesthetic vision. **Artists can check the Stover Mill Gallery website after September 16, 2017, for the accepted artists list.**

Submission: Each artist may submit one piece for consideration.

- Hanging art must be framed or with finished edges and be securely wired and not exceed a weight of 15 pounds. Maximum height or width, including frame, is 36 inches.
- Sculpture must be free standing and may not weigh more than 75 pounds, may be provided with a base (if appropriate) and may not exceed 24 x 24 inches of floor space. No suspended sculpture.

*Please do not send original art for consideration by the jury- see application procedure

Application Procedure: Completed applications must be received **BEFORE September 6, 2017**, along with a CD with unaltered JPEG image, and accompanied by a non-refundable \$20 application fee (check or money order) made payable to “**Tinicum Civic Association**”. The application form, CD, and entry fee is to be mailed to:
Stover Mill Gallery, PO Box 106, Erwinna, PA 18920.

Return of the CDs: If you would like your CD with unaccepted work returned, you **MUST include a SASE**. CDs with images of accepted work will be retained by the Stover Mill Gallery for publicity purposes.

Delivery: Accepted artists are responsible for delivering to and picking up their work from the Stover Mill Gallery, 852 River Road, Erwinna, PA 18920.

Monday, October 9th 4:30 pm to 6:30 pm

Pick up times will be:

Sunday, November 5th 4 pm to 6 pm
Monday, November 6th 10 am to noon
Thereafter, by appointment.

Exhibition Schedule: The gallery will be open 1 to 5 pm on Saturdays and Sundays, beginning on Saturday, October 14 through Sunday, November 5.

The opening reception will be held on Sunday, October 15, 1 to 5 pm.
All work is insured for the duration of the show.
